“ Financial Support of COVID-19 Items and Identity Protection with Blockchain technology for Universal Digital Access “

Overview:

The foundation aims to present directions for poverty eradication and well-being, as well as transparent identity management and financial support. The content of income sharing through blockchain finance, which is an essential technology necessary for this, will be discussed at this meeting.

According to the roadmap for digital cooperation of the United Nations Secretary-General in May 2020 (A/74/821), more than 1 billion individuals worldwide lack legal personal identification information and having trouble with accessing basic goods and services. A “good” digital identity management that preserves people’s privacy and controls over their information can empower them to gain access to these much-needed services. He reported it with seriousness and urgency of a legit digital identity system.

Blockchain technology can be used as a technology to solve these problems. Identity management and financial support can also be improved at the same time. International organizations from 110 cities, including IGO’s and NGO’s and Governor, participated in the MobiDollar project so as to protect the Survival Human Rights of 1 billion people. Therefore Foundation of the International Servant leadership Exchange Association announces MobiDollar as a common currency that was resolved at the 2019 United Nations conference in Geneva to help achieve the goal 1 and 2 of the Agenda 2030 and the Smart-ID Free Pass for verifying legal Identities.

These announcements, along with ‘Identification for Development’, ‘Global Blockchain

Finance Committee, and ISEA Foundation's Project will promote national economic and social development through this initiative. And with regard to Blockchain Financial Mechanism for Survival Human Rights, some of it can be found in the General Assembly document (A / HRC / 45 / NGO / 3).

Researchers have observed that surveillance technologies have, in many situations, allowing for serious breaches of privacy, by governments, individuals, and the private sector. The United Nations Secretary-general's report states that blockchain technology, recognized and transparent anywhere in the world, must be used for identity protection and financial support.

The organization announces MobiDollar as a common currency around the world to help global citizens seize information and economic initiatives in a democratic manner. It also aims for inviolable and safe identity protection as well as accessible financial support through MobiDollar using Blockchain technology designed to be shared by everyone without relying on specific governments and institutions..
