The Administrator of the United Nations Development Programme (UNDP) will submit a report on the progress made in 2023 and 2024 in implementing the Buenos Aires Plan of Action, the new directions strategy for South-South cooperation, the Nairobi outcome document of the High-level United Nations Conference on South-South Cooperation and the Buenos Aires outcome document of the second High-level United Nations Conference on South-South Cooperation. The report is being submitted in accordance with decisions 21/1 and 21/2 of the High-level Committee and recommendations 37 (a), (b) and (c) of the Buenos Aires Plan of Action, as endorsed by the General Assembly in its resolution [33/134](#).

The report, prepared by the United Nations Office for South-South Cooperation, will be focused on the activities undertaken by developing and developed countries, international organizations, the private sector and civil society entities relating to the objectives of South-South cooperation and triangular cooperation as set out in the above-mentioned frameworks.

The report will also serve to highlight support provided by United Nations organizations to institutions and networks of Member States to advance South-South and triangular cooperation and to foster capacity development and technology transfer, while raising funds and forging partnerships for the same purpose.
