

## **Accelerating Social Progress to Boost SDG Implementation: A UN DESA Global Policy Dialogue**

### **Concept note**

#### **Introduction**

With just five years remaining to realize the 2030 Agenda, the world faces a deepening social crisis. Economic insecurity, widening inequalities, and declining social trust undermine progress toward the Sustainable Development Goals (SDGs) and threaten the foundations of peaceful, inclusive societies. The [\*World Social Report 2025\*](#) from the United Nations Department of Economic and Social Affairs (UN DESA) underscores the urgent need for transformative policy action to reverse these trends and accelerate progress.

Despite significant gains in poverty reduction, more than 2.8 billion people continue to live on just \$2.15 to \$6.85 per day, leaving them highly vulnerable to shocks. Precarious employment, growing income inequality, and persistent discrimination based on race, gender, and other measures are reinforcing cycles of exclusion and insecurity. At the same time, trust in public institutions is eroding rapidly, with over half the global population expressing little or no confidence in their governments.

To confront these challenges, the [\*World Social Report 2025\*](#) calls for a renewed policy consensus grounded in equity, economic security, and solidarity—principles essential to building inclusive societies and resilient economies.

UN DESA will organize a Global Policy Dialogue to explore how these principles can guide integrated policy solutions to advance several of the SDGs under review at this year's High-level Political Forum: SDG 3 (Good Health and Well-being), SDG 5 (Gender Equality), SDG 8 (Decent Work and Economic Growth), and SDG 17 (Partnerships for the Goals). Drawing on the insights of UN High-level Advisory Board members on Economic and Social Affairs (HLAB), the event will feature two high-level panel discussions, interactive polls, and audience Q&A. It aims to generate actionable recommendations for governments and stakeholders to help restore trust, expand opportunity, and accelerate SDG implementation through inclusive, people-centered policy innovation.

This dialogue is made possible by the UN Peace and Development Trust Fund and will feature an in-person (if in a conference room) and online audience. All are welcome to join.

### **Format**

The 90-minute event will feature opening remarks, a video presentation, two panel discussions, and an audience Q&A session. The discussion will be interactive and led by a professional moderator. Time will be reserved during the polls. The audience will be invited to submit questions in advance at registration and during the session using Slido.

### **Location**

The event will be held in a hybrid format, in a conference room at UN Headquarters in New York or with in-person speakers and an in-person and online audience.

### **Platform**

The event will be produced with the support of the SDG Studio technical crew. It will be streamed live on Zoom, UN DESA's Facebook Page, and UN WebTV. The audience can access the online Slido platform (via QR code and/or provided link) to participate in the polls, submit their questions, or vote up questions posed by others.

The event will be in English with online multilingual captioning available in the six UN languages where possible.
