

The Online Symposium in the UN on the Abductions Issue

Opening a Window of Opportunity for the Immediate Resolution of the Abductions Issue

The issue of abductions by North Korea is not a historical event but an ongoing problem, with victims still being denied all freedoms and unable to return home, constituting an international challenge that requires immediate resolution. Japan, Australia, the Republic of Korea, the United States and the European Union will co-host an online symposium on the issue, as a side event of the UN.

The symposium will present an appeal by the families of victims from Japan and other countries. Experts on the situation concerning North Korea will join to discuss and deepen understanding on ways for the immediate resolution of the abductions issue and its importance to the international community.
